



**Fort Collins Museum & Discovery Science Center  
Enterprise Zone Tax Incentive**

The Enterprise Zone Program is a tax incentive to encourage job growth and contributions in our area. On March 11, 2010, the Office of Economic Development and International Trade approved the Fort Collins Museum & Discovery Science Center to be an Enterprise Zone Project.

Colorado State's Enterprise Zone legislation permits a 25% tax credit, with an annual credit limit of \$100,000, for Colorado taxpayers who make cash contributions to the Fort Collins Museum & Discovery Science Center. In-kind and stock contributions receive a 12.5% tax credit. The following example illustrates how a contribution of \$1,000 may impact your federal and state tax liabilities thereby lessening the cost of your donation.
